REPORTS FROM COUNTY & DISTRICT COUNCILLORS: Somerset County Councillor Mrs C Lawrence and District Councillor S Dowding reported on current matters of interest.

3. MINUTES OF MEETING HELD ON 14 NOVEMBER 2018 & MATTERS ARISING

The Minutes of the Meeting held on 14 November 2018 were approved and signed by the Chairman.

4. CHAIRMAN'S REPORT

5. REPORTS FROM COUNCILLORS

- 5.1. Environment Councillor Skinner no reports of any fly tipping. Attention was drawn to some fly tipping in Culverhayes Lane and at Quantockside.
- 5.2. Police Liaison & Neighbourhood Watch Councillor Harrison –a parishioner had been the victim of an internet crime where their computer had become locked and they were held to ransom.
- 5.3. Rights of Way no report.
- 5.4. Roads Councillor Andersen works had been finished at Culverhayes, which would hopefully have a positive impact this winter. He thanked County Councillor Mrs Lawrence for her help with this matter.
- 5.5. Community Resilience & Bicknoller Volunteer Group Councillor Grellier one of the Group had found human faeces inside the bus shelter at Church Lane. Councillor Grellier had put notices asking people not to use bus shelters as toilets. Councillor Harrison had reported this to PCSO Peter Bolton but had received no reply. District Councillor Dowding had asked WSC Environmental Health if there was anything they could do.
- 5.6. Quantock Hills & Farming– Councillor Rawle the Quantock Landscape Partnership Scheme were proposing to build a new car park at Crowcombe Park Gate. This would have affected the Parish as they were going to restore the original car park back to heathland by the use of spoil from Halsway Quarry. This proposal would also affect the water supply for Halsway. The Quantock Commoners had informed them about the water supply and they have now said they will look for alternative places for the spoil.

The Quantock Commoners were still complaining about the fencing at Bicknoller Quarry as they felt it should have been enclosed all the way around. They also advise that the old wire was never taken away by West Somerset Council when they erected new fencing in the left hand corner and sheep have become tangled up in this. District Councillor Dowding agreed to look into this.

- To keep the precept at £3,675.00. The Chairman and the Clerk signed the precept form.

It was resolved to include the equipment held by the Volunteer Group and to look into the matter of whether Woolston Moor should have a valuation put on it. The ownership of Little Moor was also questioned and the Clerk agreed to look into this.
